Message from the Chairman Chief Executive Officer

Hello GMMQ members and welcome to our 2023 Annual Report.

The Guild has published annual activity reports since 2012 (previously biennial). This report is a valuable source of information that enables our members to properly assess their association's performance in terms of finance, labor relations, communications, associative life and political representations.

First of all, we should be delighted with the year 2023, which was excellent in terms of the number of contracts filed and premium income. In 2023, the GMMQ collected revenues of \$1.8 million - a record. In terms of membership, on December 31 the GMMQ had 3,244 members, above the average of 3,177 in recent years.

Political representations

The past year was marked by advocacy activities focused on the future directions of the Canadian Radio-television and Television Commission (CRTC), the modernization of Broadcasting Act C-11, Copyright in the Age of Artificial Intelligence, and the review of provincial cultural funding practices.

For the CRTC consultations, we worked in collaboration with UDA, SARTEC and ARRQ, and submitted two briefs with the help of an external consultant.

We also worked with the <u>AFM Canadian Office</u> and our partner associations to make recommendations on Bill C-11, <u>passed on April 27, 2023.</u>

Again with our union partners in Quebec, we took part in the Consultation led by Innovation, Science and Economic Development Canada on generative artificial intelligence in the specific context of copyright.

At the provincial level, we have written <u>a letter to the Premier</u> and the Minister of Culture, asking them to bring together all the players in the industry - producers, distributors, broadcasters and creators - to redefine the mechanisms for allocating, distributing and circulating public funds.

Community life

The **102nd AFM** (American Federation of musicians) **convention was** held from June 26 to 29, 2023 in Las Vegas. Following the departures of President Ray Hair and Secretary-Treasurer Jay Blumenthal, there was a race for the leadership of the Federation and several candidates for the positions of directors. The GMMQ-Local 406 delegates to the convention were myself, Eric Lefebvre, secretary-treasurer, and director Vincent Seguin. Your President ran for the position of Director, with aspiring President Tino Gagliardi and Secretary-Treasurer candidate Ken Shirk. The delegates elected me to the Board, along with Dusty Kelly, General Manager of the Toronto Musicians' Association - AFM Local 149. This was the first time that Canadians have been



elected as officers, apart from the *ex-officio* position of Vice-President Canada (<u>see press</u> <u>release</u>).

Lac à l'Épaule by the GMMQ Board of Directors in October

This year, the GMMQ commissioned MCE Conseil to work with the Board of Directors and the Executive Committee on a major organizational review. The broad outlines that emerged cover a variety of topics, such as: mobilization; review of administrative processes; involvement of Board members; training of directors on governance issues; modernization of by-laws; strengthening strategic alliances, notably with Union des artistes; and the need for a strategic consultation of our members in the near future. It will be up to the Guild's Board of Directors, elected in June 2024, to follow up on these recommendations.

This introduction to the annual report is my last, as my term of office ends on June 16, 2024. It has been a great privilege to serve on the Guild's management team for the past 18 years - and on the Board of Directors since 2003.

Coalitions:

The GMMQ is present in several coalitions to present a united front on issues affecting several professional associations. In 2023, it attended several meetings with the following coalitions:

15 inter-union meetings, coordinated by TACT, with ARRQ, UDA and SARTEC. This coalition is one of the most active. The meetings deal with major common issues in culture, such as the provincial budget, authors' rights, the new law on online streaming (federal), and artists' working conditions in general.

-UDA, SARTEC, Artisti and ARRQ attended a federal government consultation on artificial intelligence and copyright on October 27, 2023.

Communication is constant throughout the year with our counterparts at UDA, SPACQ, UNEQ, ARRQ, SARTEC, CQM, FAMEQ, TRACE, APASQ, ACTRA, SCGC and AJIQ, to name but a few.



The GMMQ also sits on the Board of Directors of the Fonds d'investissement de la culture et des communications (FICC).

Finally, the GMMQ sits on the Board of Directors of the Métamusique project (8 meetings), and on the Finance Committee. See <u>metamusique.ca.</u>

In addition to our annual general meetings, the GMMQ regularly organizes thematic 5@7s to bring members together to discuss common issues.

5@7 inclusion networking

On February 21, 2023, the first 5@7 of the year was held with the CAFID committee. The topic was discrimination in music in Quebec. The event was reserved for members and took place at the Guild offices. The format allowed for networking with nibbles and a glass of wine, and a small group discussion around the theme.



Our guest of honor, Allison Migeon, General Manager of the Obiora ensemble, aroused curiosity and answered questions from the members present. The creation of such an ensemble gave rise to many crosscutting themes, from the audition process to the experiences of people who have suffered discrimination in their careers.

There were 18 of us, including 5 non-Board members and 3 guests.

Inspiring parents breakfast

Our inspiring parents event was held on October 17. In the form of an open discussion, we were able to tackle several issues related to motherhood and the return to work for young mothers, but also to being a parent and an artist on a daily basis.

Many thanks to our 2 guests: Blanche Baillargeon and Amina Myriam Tébini, who came to share their experiences, and a big well done to all those who took part in the event for coming out and discussing the subject. We really wanted this event to take place.

The event was attended by 9 people, including 2 non-members. We would like to repeat this event every year.

5@7 Music events, variety-pop-jazz sector

On December 13, 2023, the Guilde des musiciens et musiciennes du Québec (GMMQ) and the Union des Artistes (UDA) invited pop, jazz & variety artists to an open 5@7 on their current concerns. The event was a joint effort to bring the two associations closer together on common objectives. The event took place at the GMMQ and UDA offices. The invitation was extended to non-members of both organizations. Some fifty artists were in attendance.



GMMQ recognition cocktail

On December 20, 2023, after the year-end general meeting, the GMMQ held its first recognition cocktail, including new life members, but also people who had made a commitment during the year, such as board members and negotiating committee members, to thank them for their involvement. Each life member was highlighted with a short biography and the presentation of "life member" pins. 60 people attended the event, including 43 life members.

Annual General Meetings:

The GMMQ held three general meetings in 2022. The hybrid format is now a given. Members can take part in the meeting both in person and virtually, via the zoom software. LABOUR RELATIONS

Summary by Louis Leclerc, Director of Labour Relations

This summary of activities is first and foremost an account of the results obtained from the various activities of the Labor Relations Department, as well as an overview of the main changes in human resources.

The year 2023 is undoubtedly a remarkable one, if not the best since 2019, in terms of revenue from practice fees. With the pandemic finally behind us, we've seen a resurgence in activity across the performing arts and ambient music sectors.

There was one downside, however: the audience did not turn out as expected. In fact, there was a significant drop in subscriptions, as well as a substantial drop in ticket sales. Unfortunately, this situation is likely to continue over the next few years. Our new challenge is to find solutions and alternatives that will enable us to offer artists acceptable conditions, while at the same time allowing us to hold diversified musical events.

In Human Resources, Catherine Forget returned full-time in July 2023 as an agent and lawyer. In September 2023, Guy Bernard, lawyer, joined the team as Senior Labour Relations Advisor. Guy took charge of negotiating collective agreements (new or renewals) and provided front-line service to the various problems inherent in labor relations (NB: Guy became General Manager of the GMMQ in February 2024).

As for negotiations, several new and renewed agreements were signed this year. To name just a few: Orchestre symphonique du Québec (OSQ), Orchestre Métropolitain (OM), Jeunesses Musicales du Canada (JMC), Orchestre symphonique de Montréal (OSM), etc.

Before concluding, I would like to point out that a mediation process is still underway with the OPQ (formerly the OSDL). This process began in March and should end in May 2024, with the ultimate goal of re-establishing a healthy, collaborative working climate between management and the orchestra's musicians.



Recovery of ADISQ service fees



In 2023, 9 newsletters were sent in French and English to GMMQ members in good standing, as well as to former members less than 2 years old and anyone who subscribed to the newsletter via the website, i.e. some 3,600 people.

L'entracte is GMMQ's 100% digital magazine. It offers in-depth content on GMMQ activities, analyses of certain media hot spots, an inspiring portrait of a GMMQ member and the various negotiation files currently underway at the GMMQ.



Media presence

Press releases (in French)

January 18: Agreement in principle between the musicians and the Orchestre symphonique de Québec.

Last week, the musicians of the Orchestre symphonique de Québec adopted an agreement in principle with the Orchestra by a clear majority. This negotiation process represented a turning point for the future of the Orchestra. Indeed, the musicians had been facing a virtual salary freeze since their last collective agreement signed in 2015, and were hoping to obtain a salary catch-up so that they could earn a decent living. Considering that inflation alone stood at 6.1% for 2022 alone, it was clear that 2015 wages were no longer sufficient for musicians to make a decent living. This new collective agreement enables musicians to achieve the main objectives they had set themselves during the negotiations. The agreement will be retroactive to 2020 and will run until 2024.

February 13: P2 visas: information on fee increase.

The American Federation of Musicians (AFM), of which GMMQ is a member, opposes the proposed visa increase by the USCIS - American Federation of Musicians. The AFM, along with many other US-based arts organizations and businesses, is lobbying against such a significant increase (over 251% - from \$460 to \$1615!). These lobbying efforts began in mid-January.

April 28, 2023: BILL C-11 - Artists' professional associations welcome Senate passage - CTVM.info Long-awaited, this modernization was more than necessary to protect and safeguard our culture. Bill C-11 is a major undertaking to modernize the Broadcasting Act. The Union des artistes (UDA), the Guilde des musiciennes et musiciens du Québec (GMMQ), the Association des réalisateurs et réalisatrices du Québec (ARRQ) and the Société des auteurs de radio, télévision et cinéma (SARTEC) were quick to speak out in favor of the process, and today welcome its adoption. Although this bill does not impose the same obligations on foreign platforms as on Canadian broadcasters, such a reform was important, and it will be up to the CRTC to ensure that it better supports Canadian artists and their talents.

December 05, 2023: <u>GENERATIVE ARTIFICIAL INTELLIGENCE (AI) AND COPYRIGHT - Warning from</u> artists' associations

As part of the consultation organized by the federal government on generative artificial intelligence in the specific context of copyright, five professional associations representing nearly 20,000 Quebec artists are calling for caution and transparency, and demanding a protective legislative framework.

Press review

In 2023, there were 36 GMMQ media appearances, an average of 3 articles per month. 72% directly concerned the GMMQ as an organization, the rest stemmed from our work in coalition with other associations.

The GMMQ's lobbying activities include appearances in the media. The press review presented in Appendix 2 of this report collates articles in which the GMMQ is directly mentioned. Some articles about our coalition work only mention the name of the coalition (without mentioning the specific organizations involved).

Events

National Suicide Prevention Week

This year, the GMMQ made a special point of highlighting National Suicide Prevention Week (February 5-11), and raising musicians' awareness of this important and hard-hitting cause in our community.



For the symphony sector, a simple project has been implemented: themed stickers have been distributed to

musicians. These sober stickers can be used, for example, on their instrument cases or other visible locations, as they choose. The stickers were produced by the Association Québécoise de Prévention du Suicide (AQPS).

The stickers were sent to the orchestras we were able to contact.

To date, 10 orchestras have received their *suicide prevention week* stickers: OSS, OSL, OSDL, OSG, OM, OSQ, OSTR, OSE, OSSLSJ and the Agora orchestra.

Their response to our initiative has been very positive.

Together, let's stop being afraid to talk about suicide in our community.

Journées de la culture

On Sunday, October 1, we celebrated music with the general public at a Forro Ball with live music! A wonderful event made possible by our partner, Studio Danse Montréal, funding from the Music Performance trust Fund, and the participation of musicians from Diogo Ramos' group, Forró Brasa: Marcelo Effori, Lissiene Neiva, Kayiri and Diogo Ramos. What a party! Some sixty people attended the event.

TRAINING COURSES

Continuing education, in partnership with CQM

For the fifth consecutive season, the GMMQ offered training courses in partnership with the CQM. These courses are funded by the Ministère de l'Emploi et de la Solidarité sociale (MESS) under the Intervention-Compétences program of the Fonds de développement régional des compétences de la main-d'œuvre (FDRCMO).

These training sessions are given by experts in their field, and are aimed at professional musicians and cultural managers, with a view to career development. For the 2023-2024 season (September 2023 to June 2024), 18 training sessions were given to 210 participants (in French), and 22 individual coaching sessions were offered.

Inclusive communication training in music 101

On April 18, 2023, Inclusive Communication in Music 101 was held. For its first edition, the course was sold out. Thirty of us attended, either on our own behalf or on behalf of an organization. Thirteen orchestras or music associations were represented. The GMMQ's CAFID committee is truly proud of the representativeness of the participants and the positive impact the training will have in terms of diversity and inclusion. Many thanks to Elsa Fortant, our trainer, and Vanessa Blais-Tremblay, professor in the Music Department at UQAM, both of whom are members of the DIG! network, whose constant collaboration is a definite plus for the GMMQ.



Diversity workshop: How can I be an ally in my environment?

On November 22, the CAFID committee and our Equity, Diversity and Inclusion coach, Julie Meloche, organized a workshop entitled Diversity: How to be an ally in my environment. The training was open to the entire sector. Its aim was to raise awareness in our community of inclusion in our environment, and to provide ideas for bringing more inclusion into our surroundings at our own level. A total of 12 people took part in the workshop.

The CAFID committee benefited from the support of an EDI (Equity, Diversity, Inclusion) consultant, financed by Competence Culture. This included 10 hours of interviews and training with committee members, between May 1 and June 20. Our coach was Julie Meloche, a graduate of the School of Transformative Leadership and a teacher on special assignment for the equity and inclusive education file in Ottawa.

In 2023, the Fonds Jean-Carignan helped **10 GMMQ members**, for a total amount distributed of **\$7,500**. **That**'s 10 people who received financial respite from a difficult situation, and that's priceless. The fund provides one-time financial assistance to professional musicians in need. It intervenes as a last resort, in a context of emergency and crisis.

We have now **helped a** total of **86 musicians** since our foundation in 2011.

This year, individual donations - your donations - enabled us to raise \$18,431. Most donations are made by members themselves when they renew their membership. A big THANK YOU! **Thanks to you, solidarity within our community takes on a concrete meaning.**

The Association des musiciens de l'OSM (AMOSM) has renewed its annual donation of \$5,000. Their support for the fund now totals \$41,000 since 2011, making them the largest corporate donor to the Fonds Jean-Carignan. A special thank you to the musicians of the OSM, who have shown such great support for our community. The GMMQ extends its sincerest thanks to them.



*We wish to emphasize that all Fonds Jean-Carignan activities are carried out on a voluntary basis by the entire team. No fees are charged to the Fund by the GMMQ. Only 2.24% of our revenues go to management fees for our investments, which are managed by the Fondation des Artistes du Québec in a separate silo.
